## INDIVIDUAL PROJECT DESCRIPTION >

While *waqf*-s (endowments to pious foundations) are considered a central institution in Islam, the formation of Islamic manuscript and art collections worldwide suggests the institution underwent severe dislocation from the late 18<sup>th</sup> c. onwards. More and more portable artefacts from Islamic foundations were channelled to secular places, such as library and museum holdings, mostly in Europe and the US, but also in the Middle East, where portable assets were systematically relocated to museums or libraries from the 1880s onwards. The modern reconfiguration of tangible heritage collections from and in the Islamic world, whether connected to Orientalist knowledge, the colonial and national invention of tradition or the current reclaiming of Arab heritage by collectors and institutions in the Gulf, offers plenty of evidence for a study of the transformation of a major Islamic

institution through its gradual commodification. The process can be observed through the study of selected collections of manuscripts and personal libraries (such as the one assembled by the Egyptian scholar Ahmad Zaki in the early 20<sup>th</sup> c.), which still exist today. In the past two decades, these holdings experienced another fundamental transformation: large numbers of manuscripts have been digitised (with varying degrees of consideration for copyright). An inquiry into how the availability of these collections has shaped scholarly practices will help us understand how the emergence of a new medium can impact scholarship.

### Essential criteria:

- Master level degree (or equivalent) in History, Social Studies, Middle Eastern Languages and Studies or other similar domains
- ETS TOEFL certificate (min. 600 for paper-based test, 250 for computer-based test, 100 for internet-based test) ; Cambridge Certificate of Proficiency in English, CPE (any grade) ; Cambridge Certificate in Advanced English, CAE (grade A or B) ; IELTS test (level 7.0)
- Applicants who are native speakers or applicants who have graduated from an English speaking university in a country with English as an official language are exempted from this verification
- Fluency in written Arabic
- Commitment to collaborate in the general development of the project

### Desirable criteria:

- Experience in working in an interdisciplinary team
- Experience in working with digital tools in data management
- Relevant MA thesis
